POLICY ON DETERMINATION OF MATERIAL SUBSIDIARY

A material subsidiary shall mean a subsidiary, the income or net worth of which exceeds twenty percent of the consolidated income or net worth, respectively, of the company and its subsidiaries in the immediately preceding accounting year.
